

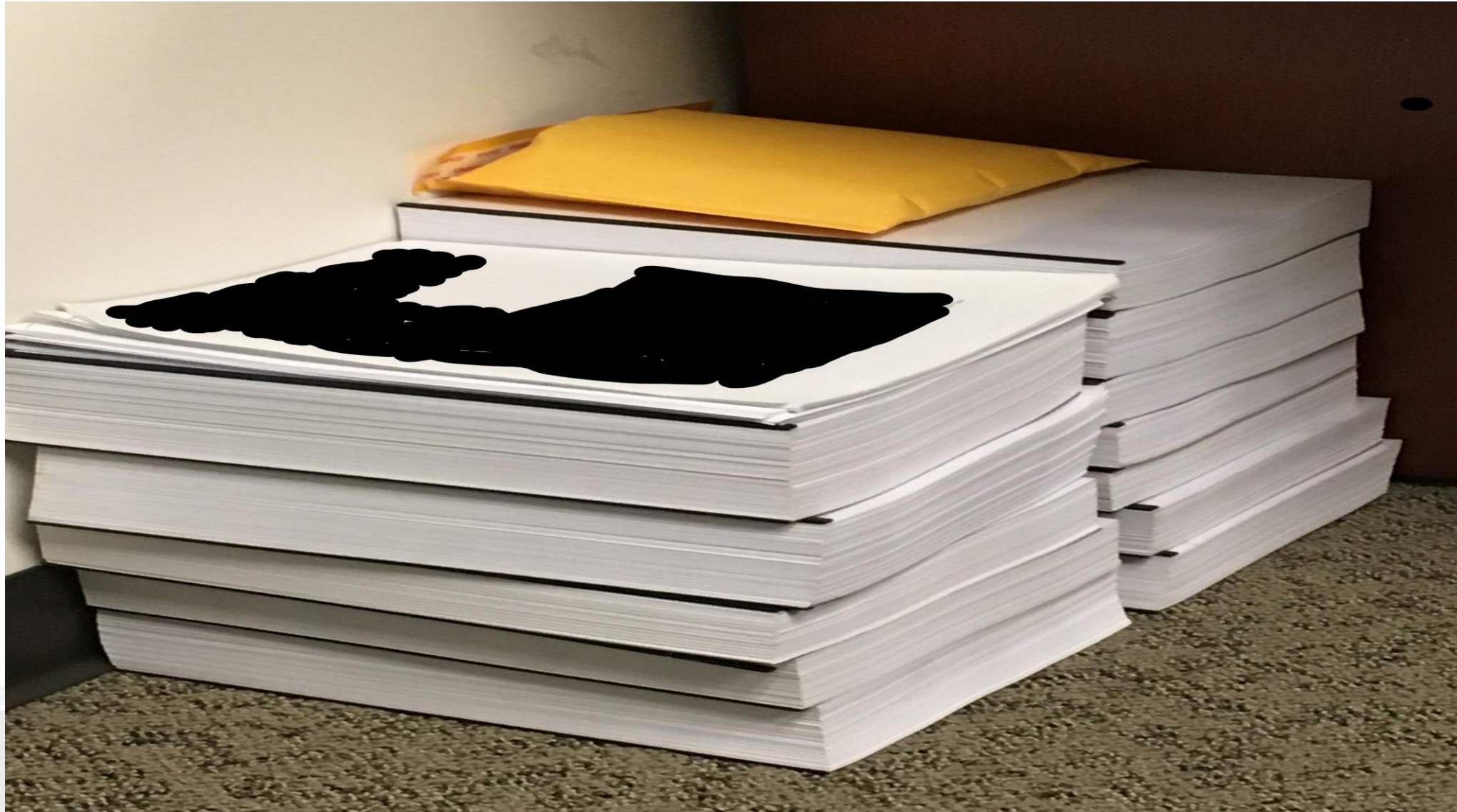

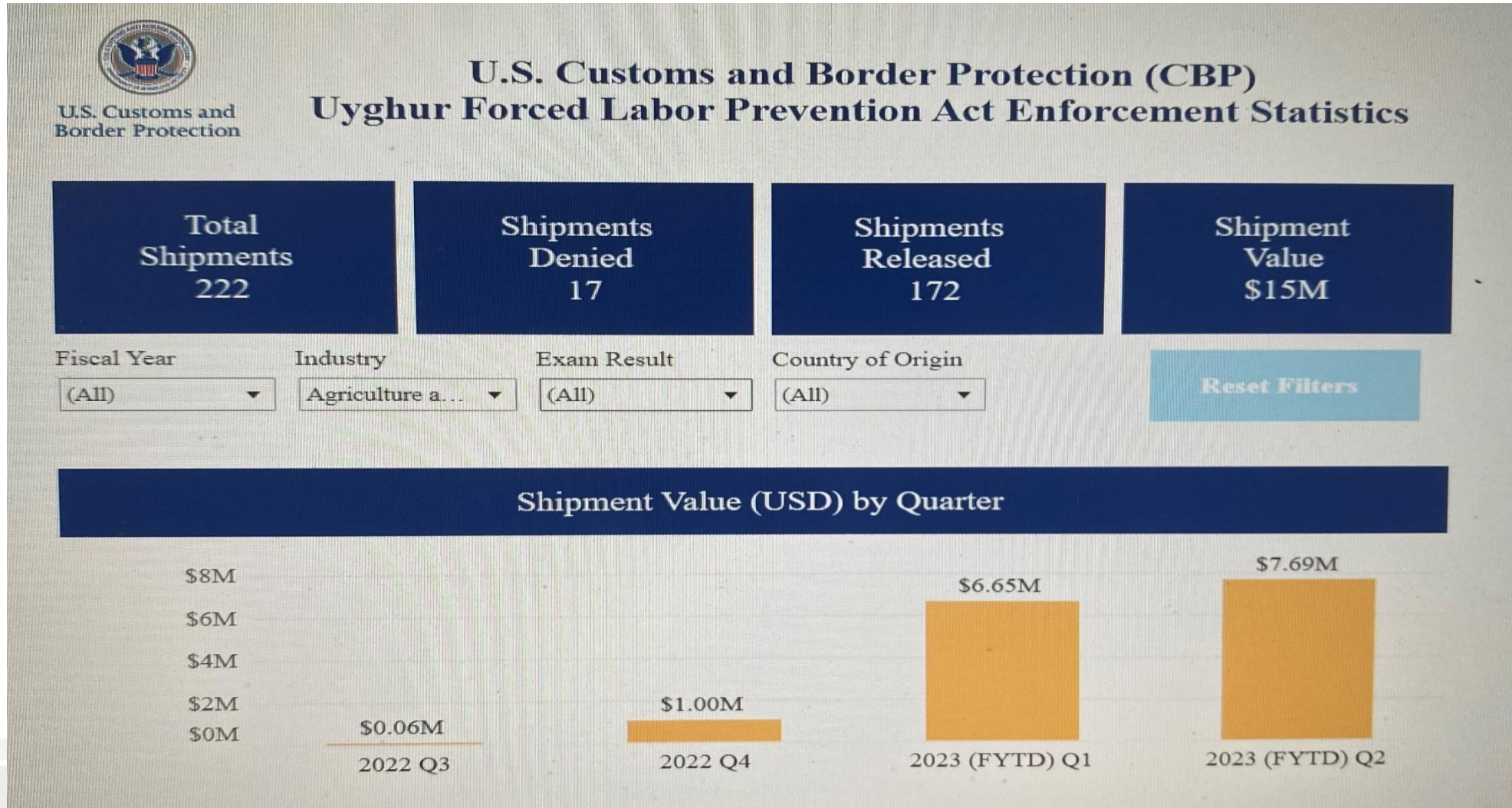

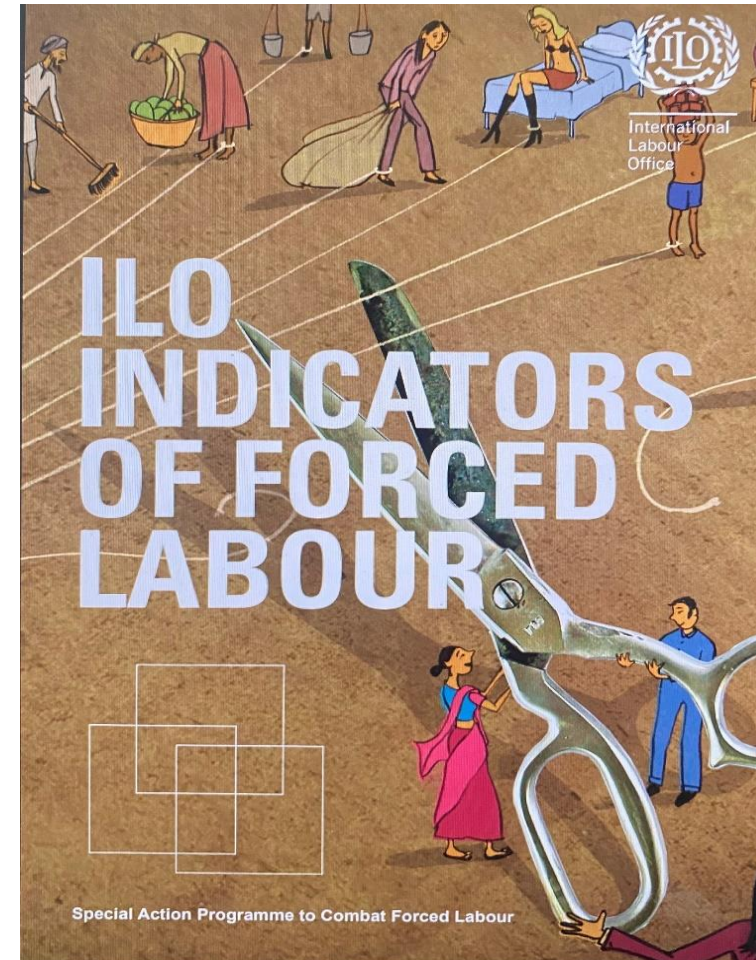

Social Responsibility

- Importers must exercise reasonable care over their supply chains and understand where and how their products are manufactured or produced, in whole or in part. The Department of Labor (DOL) produces reports on forced labor and its Comply Chain application outlines critical elements of a social compliance program. Additionally, importers may monitor CBP's website, which lists all foreign entities and respective commodities subject to an active WRO or Finding. Further, the Office of Trade has identified interrelated sound business practices that can serve as the foundation of an effective forced labor/corporate social responsibility program.
